During 2022 BWM, Inc., served a total of 959 clients with a total of 6115 clinical encounters. In 2022 BWM, Inc. provided \$12,800 in pro bono services and \$22,420 in reduced rate services. Charitable donations received by BWM, Inc. included a total of \$5,381 by founding members Tammy and Norman Carvalho (made over the course of 2022 to allow BWM, Inc. to meet expenses). Kissimmee Utility Authority made a \$5,000 grant to BWM in 2022 and BWM, Inc. continues to counsel homeless clients in conjunction with Church and Community Association Program (CCAP).
