During 2024 BWM-Inc served 886 clients with 7647 encounters. This included 196 reduced cost clinical encounters (\$19,422.00 BWM subsidy towards towards these encounters) and \$31,570 in pro bono care in 214 clinical encounters. In 2024 BWM-Inc donated \$4,694.25 to charitable causes (\$3,019 to Oasis Church). The total charitable impact of BWM-Inc in 2024 was \$55,686.25.
